

# The reimbursement process



### **HEALTH CARE IN BELGIUM**

- Belgium offers a **public** health care system of high-quality
- Free choice of doctor, hospital, pharmacy, etc.
- Partial reimbursement of health care expenses: Doctor (also dentist and specialist), Medicines and Hospital
- Reimbursements are based on the national price fixed by the National Institute for Sickness and Invalidity Insurance (INAMI/RIZIV).

#### **HEALTH CARE IN BELGIUM**

#### Process for reimbursement





Put your identification **sticker** on it and send us the original claims for reimbursement **by post** or drop them in **an agency** nearby.







**Hospital:** Call and make an appointment. Show Your ID/Resident card or Helan sticker at the entrance.

Pay the visit and send us the claims for reimbursement, don't forget to put your identification sticker on it

**Emergency:** Go directly to the hospital via the emergency services.





Show the **medical prescription**, your ID/Resident card or the Helan sticker If, You don't have an ID/Resident card, or Helan sticker yet? Ask for the **annex 30**, put your sticker on it and send us the receipt for reimbursement

## **Registration process for European Students**



You come from EU?

=> Registration for **free** for 1 year minus 1 day (can be extended by 1 year)

#### Registration form for temporary stay in Belgium



Foreign ID Card

- Complete and sign the EHIC registration form
- Provide us with a copy of your European card (validity + 3 months)
- A copy of your foreign ID card

## **Registration process for Non-european Students**

- No registration at the city hall yet or in progress:

  Complete and sign the registration form both sides

  Provide us the following document:
  - ✓ School certificate
  - ✓ Copy of passport
- Scan all the documents to the following address: <u>students@healthinsurance.be</u>
- Student fees per quarter for Helan is 103,22 €
- After your registration is completed at the city hall, you will have the
  possibility to switch your status to resident so that you won't have to pay
  103,22€/quarter but only <9,50€/month with a lot of extra advantages.</li>
